**VOLUNTARY WAIVER AND RELEASE**

This Voluntary Waiver and Release Agreement ("Release") is made to allow myself/my child to participate at the Houston Amateur Sports Park and its sponsored events. I recognize that my signature on this Release is a condition of your permitting myself/my child to participate. I agree that you may photograph and/or videotape myself/my child during activity and its sponsored events and that you retain the rights to use these visual images in any manner you wish without compensation to me/my child. I further agree that you may use and license others to use my name/my child's name, voice, likeness, and any biographical facts which may have been provided to you, including advertising and promoting the Houston Amateur Sports Park and its sponsored events.

I certify that my child/self is in suitable physical health, and may participate in strenuous and potentially hazardous physical activities. I certify that I have listed any known physical limits to my child's/self participation at the Houston Amateur Sports Park and its sponsored events on the back of this waiver. Permission is granted for myself/my child to receive emergency medical treatment if needed, and I agree that I shall be responsible for any and all costs of medical coverage and treatment provided not covered by insurance. I expressly and unconditionally assume all risks and dangers known or unknown, foreseen or unforeseen, and relating or incidental to myself/my child's involvement at the Houston Amateur Sports Park and sponsored events and I hereby release and discharge Dynamo Soccer, LLC, Major League Soccer, L.L.C., and all their affiliated entities and each of their officers, employees, partners, shareholders, members, owners, sponsors, contractors, volunteers, agents, successors and assigns ("Releasees") from any and all liability, claims, demands, and causes of action for personal injury, property damage, and/or other loss suffered by myself/my child in connection with his /her participation at Houston Amateur Sports Park and sponsored events. I agree to defend and hold the Releasees harmless from any loss or damages, including attorneys' fees and costs, sustained by the Releasees, or any one or more of them, as a result of any rescission of this Release or breach of its covenants or agreements contained herein.
